Annotated Bibliography

Problem-Solution Injustice Panel Presentation

In order to prove the usefulness of your sources to me for The Problem-Solution Injustice Panel Presentation, you are going to be completing an annotated bibliography. Annotated bibliographies take a simple works cited page to the next level and can be a very helpful tool during research to analyze the efficacy of your sources. In a bibliography (or works cited or works referenced as we call them) the writer lists the sources they used, either in their paper or during their research. Annotating something is interacting (summarizing, evaluating, assessing, reflecting) with it. In an annotated bibliography you will be doing both of these things.

After finding the **sources** you need for this project, you will need to write your annotated bibliography. This should include:

- 1. A correct MLA citation of your source
- 2. A paragraph explaining the usefulness of that source for your panel presentation. In this paragraph you need to **summarize**, **analyze**/ **assess**, **and reflect** on each source.
 - a. <u>Summarize</u> Provide an overview/paraphrase of what the source tells you. What is the point of the book or article? What topics are covered? If someone asked you what this source was about, what would you tell them?
 - b. <u>Analyze/Assess</u> Provide an evaluation of this source. Is it a useful source? How does this source compare with other sources? Is this source biased? Objective? Reliable? What is the goal of it? If there is information presented that you are unsure or unclear about, this is the time to bring that up.
 - c. <u>Reflect</u> After both summarizing and analyzing the source, you need to tell where in your discussion you plan on using the information presented. How does this help you shape your ideas?
 - d. Please note: The majority of your annotation should be the analysis and reflection portion. While the summary of your source is important, it shouldn't take more than a few sentences. What I really want to see from you is evidence of critical thinking about the sources you chose and how they will fit into your final presentation.
- 3. The format of your annotated bibliography should follow MLA guidelines. Your citation should be correctly formatted and punctuated, as well as have a hanging indent. The annotation should be written in paragraph form with a hanging indent as well. Everything should be single spaced for this assignment. Please look at the example on the back of this sheet for formatting rules and an example of what should be included in the annotation.

Your final annotated bib will be due Thursday of next week – typed and printed. Please use your time in the Media Center wisely so you can complete this. Remember, your panel presentations will begin Thursday also!

Are You Trapped by Prostitution? Perf. Karen Green. I Am Second, 2012. Interview.

More recently they have taken their efforts a step further in the Blue Campaign of 2010 that elaborated on their awareness efforts and the training they are supplying to government regarding sex trafficking. Seeing that this website is funded directly by the U.S. and ran by officials on the board of Homeland Security, I have confidence in the accuracy and truth to the information that was given. Many aspects are covered in the book regarding trafficking. To open, it talks of an interview with a patrol person watching for smuggled objects coming acrossed the border. The interviewer, Nick, asks if they watch for traffickers and the response was that trafficking is inevitable and that there is no need to try and stop them. It also goes into depth about what would be an appropriate approach to take to be the most beneficial in decreasing trafficking prevalence. For a while, legalize-and-regulate was the model they went by. When that proved insufficient, they took on the model of crackdowns and providing services to saved victims.
